I. Objectives of the Steering Committee

II. Organizational Form

The Steering Committee of ENETOSH is an independent association. Members can be legal entities and natural persons.

III. Work Packages

1. Coordination and Facilitation

Work Package 1 comprises the reporting, preparation and coordination of the meetings and activities as well as the meeting of the ENETOSH members for the implementation of ENETOSH.

2. Quality Management

Work Package 2 comprises the definition of the quality policy of ENETOSH and the ongoing further development of the quality management.

Projects

Work Package 3 comprises the joint preparation and performance of projects, including the pooling of possible partners and the acquisition of funds.

4. Evaluation

Work Package 4 comprises the internal and external evaluation of ENETOSH.

5. Promotion

Work Package 5 comprises the definition of the ENETOSH label and the representation of ENETOSH to the outside.

6. Events

Work Package 6 comprises the initiation, preparation and performance of joint events.

IV. Work Mode

The members of the Steering Committee agree on contributing their know-how and resources for the purpose of informing each other of their planning and experiences and thus of their mutual support in the management and implementation of ENETOSH.

If required, work package leaders will be appointed for the individual work packages.

The Steering Committee will convene in regular intervals (twice a year). The convention may be carried out in connection with a regular ENETOSH network meeting.

As part of such meetings, the results of the Work Packages will be introduced, discussed and the future approach coordinated. Moreover and if it is desired, external experts shall be invited to inform on current topics and to support the work of the Steering Committee.

Beyond potential meetings of the Work Packages and of the Steering Committee, there will be an exchange among the members of the Steering Committee.

The closed area of the ENETOSH platform shall serve members of the Steering Committee for an exchange of information and documents. General communication shall be effected by e-mail.
